### Scope of Work

- Design and develop training manuals, modules, and teaching aids aligned with modern educational standards.

## 3. Activity-Based Teaching:

- Promote interactive and experiential learning methods in classrooms to improve student engagement and learning outcomes.

## 4. Pedagogical Knowledge Transfer:

- Introduce innovative teaching approaches such as blended learning, flipped classrooms, and competency-based education.
